

# Forest Ridge Association Board of Trustees Regular Meeting May 19, 2014

**Trustees Present**: Bob Gray, Sue Hanley, Roberta Havholm, Shelton Monger, Jennifer Kelley and Jake Bontatibus

Trustees Absent: Chuck Evanhoe, Collin Monger and Greg Herman

Bob Gray called the meeting to order at 7:30 p.m.

**Police Report**: Officer Warner was present from the Dayton Police Department and reported on the area crimes for the past month. There were only seven crimes this past month – three shoplifting and four thefts from buildings. The board discussed issues with speeding and running stop signs. Officer Warner said they could post a speed van that takes pictures and sends tickets to speeders.

Visitors: No visitors were present.

Northeast Priority Board: No report.

**Minutes**: Jake Bontatibus moved that the April 21, 2014 meeting minutes be accepted with corrections. Roberta Havholm seconded.

#### **Vote** 5-0

**Treasurer**: Dan Freeman, Treasurer, reported on the financials. The General Fund balance is \$172,243.19. Replacement reserve balance is \$91,274.51. We received 32 full and 4 partial assessments (\$7,477.17) in April, and we've received 36 full and 4 partials (\$8,219.00) so far this month; so there are 114 full and 7 partial assessments still open (\$25,450.00). This compares to 104 assessments (\$23,258.00) still open at the same time in 2013.

Shelton Monger moved that the report be accepted. Jennifer Kelley seconded.

# **Vote** 6-0

**Murmurs**: Roberta Havholm discussed the June issue. The pertinent articles will be the Soccer Information, Pool Rules, and Graduate Recognition. Deadline for article submission is May 23<sup>rd</sup>, 2014. It will be delivered the first weekend of June.

**Communications Committee Report**: Bob Gray reported that two welcome packet were delivered, and there have been four recent sales.

Website: No report.

**Pool**: Ellie Monger, the pool manager, reported that the new motor is in the process of being installed. She also said inspections will be done by the end of the week and everything will be ready for opening on Saturday. She said she has a great staff this year.

**Pool and Outdoor Recreation Committee:** Shelton Monger discussed the upcoming swim/pool season. He discussed the maintenance being done around and in the pools including some issues with one of the pumps that will need replacement. He also said that all swim officials in the Miami Valley will be at the pool on June 7th.

Jesse Morgan reported that spring soccer is wrapping up. He had more kids this year than last. He will be looking to additional ways to publicize over the summer for Fall soccer.

#### **Green Areas:**

Mitch Bird, green area supervisor reported on Green Area activity: Current Projects: Mowing, Filled cracks at Willow Branch tennis courts, Edging curbs and sidewalks, Tree work at sign area and Blvd. playground, Soccer field work and mowing inside pool will end this week. **Equipment:** Ordered new belts for large area mower, Fixed starting problem on Grasshopper

Sue Hanley asked about the status of the bridge rails. Jake said that would not likely happen until after June. Sue also asked about a piece of damaged playground equipment. Jake said they would fix it as soon as possible.

**Asset Management Committee:** Jake Bontatibus discussed the status of the tree removal. The Lesco mower was traded for additional tree work, as it is no longer serviceable. He discussed the quote for a replacement mower. They got a quote for a Scag mower for \$10,510.50. Jake Bontatibus made a motion to purchase the mower. Roberta Havholm seconded.

#### **Vote** 6-0

The board asked Mitch to identify which sidewalks bordering Green Areas need to be replaced. Jake suggested doing as many at once to save money.

**Old Business**: The board discussed several distressed properties in Forest Ridge. Sue Hanley reported several homes to the City of Dayton. Bob Gray reported several homes to the City of Riverside.

Shelton Monger discussed another local HOA that was able to change the bylaws of the association with the help of a lawyer. The board discussed the possibility of doing something similar. Shelton Monger is going to follow up, and Sue Hanley is going to check with UD Law School

#### Sue Hanley discussed the garage sale.

There were issues with residents asking to have their addresses put on the map. It is recommended that next year addresses be accepted by e mail or a registration form only. Both Bev Pendergast and Sue have declined to be the chairs next year. There were questions from the board as to whether the garage sale was worth the effort.

The board discussed the gazebo and the possibility of repairing it. The asset committee had a professional construction company look at it. The company said everything looked ok. Mitch agreed to get a roofing expert to review as well. The board decided to look at the possibility of including it in next year's budget

**New Business:** The volunteer picnic is scheduled for August 10<sup>th</sup>. Jennifer Kelley agreed to be in charge of the event.

Jake Bontatibus asked about the schedule for monthly meetings, and the board said that meetings are scheduled according to the bylaws.

Jake also asked about the possibility of a field day. The board suggested putting a budget together to submit at the budget meeting in November.

Jesse Morgan suggested a Frisbee golf course and a picnic pavilion.

Jake discussed the Dayton mini-grant program. Sue said it would be difficult getting the people involved that are required for the program. The board decided to possibly work on it next year and budget it in November.

**Adjournment**: Shelton Monger moved the meeting be adjourned and Jake Bontatibus seconded.

The meeting ended at 9:16 p.m.

# Forest Ridge Association Board of Trustees Regular Meeting June 16, 2014

Trustees Present: Bob Gray, Sue Hanley, Roberta Havholm, Greg Herman, Chuck Evanhoe and Jake Bontatibus

Trustees Absent: Shelton Monger, Jennifer Kelley and Collin Monger

Bob Gray called the meeting to order at 7:30 p.m.

Police Report: Officer Warner was present from the Dayton Police Department and reported on the area crimes for the past month. There were only two property crimes this past month – one theft from building and one other theft. The other crimes reported were two simple assaults, one menacing and two other offenses. The board asked about the speed van that takes pictures and sends tickets to speeders. The board also noted that the stop sign that had been obscured was now visible.

Visitors: No visitors were present.

Northeast Priority Board: No report.

Minutes: Jake Bontatibus moved that the May 19, 2014 meeting minutes be accepted with corrections. Roberta Havholm seconded.

#### Vote 6-0

Treasurer: Dan Freeman, Treasurer, was not present but provided the financials. The General Fund balance is \$120,019.59. Replacement reserve balance is \$91,276.71. We received 32 full and 3 partial assessments (\$7,218.00) in May, and we've received 6 full and 4 partials (\$1,326.00) so far this month; so there are 79 full and 8 partial assessments still open (\$18,057.00). This compares to 68 assessments (\$15,356.00) still open at the same time in 2013.

The board tabled approval of the financial reports until questions are answered about various expenses.

Murmurs: Roberta Havholm reported there would no Murmurs in July. She is also very pleased with the Boy Scouts deliveries.

Communications Committee Report: Bob Gray reported that three welcome packets were delivered, and there are five pending deliveries.

Website: There have been 6300 page views so far this year. Our Facebook site has over 790 likes.

Pool: Ellie Monger was not present but submitted the following report:

The health inspector came last week and we passed our inspection. She generally comes every two weeks.

I held a meeting with all the guards to discuss several topics:

- 1. Made sure that everyone knew how to test chemicals.
- 2. Made sure everyone knew procedures for amount of guards on chairs.
- 3. Talked about customer service.
- 4. Talked about contacts while I am away this week.
- 5. We covered duties and expectations to include morning, afternoon, and evening jobs.
- 6. We covered keeping the pools vacuumed and grounds kept nice—mowing.
- 7. Swim lessons begin this week-June 16-June 27. We have 24 children signed up.
- 8. Swim Team has their first meet on Tuesday the 17th. The pool will close at 4:00pm.
- 9. We had our first pool party this past Friday. Another is scheduled for this coming Friday.
- 10. We have a few others coming up as well.
- 11. A couple of assessments have been received at the pool.
- 12. A replacement water fountain was installed.

Pool and Outdoor Recreation Committee: Chuck Evanhoe reported that the pool staff is beginning work on policies and procedures.

Greg Herman reported that "Music at the Gazebo" starts this Sunday.

#### Green Areas

Mitch Bird, green area supervisor, thanked the board for purchasing the new mower. He reported on the following Green Area activity:

Current Projects: Mowing, Installed rails on soccer bridge, Removed broken basketball goal post from Willow Branch, Filling cracks in tennis courts is about half complete, Wood line trimming, Edging curbs and sidewalks – edger broke and needs to be replaced, Cleaned gutters on both buildings.

To Do: Mulch, Finish filling cracks in tennis courts and paint, Paint two playgrounds, Wood line work, Replacement of goal posts at Willow Branch basketball court, Mow & clear hiking trails, Apply herbicide and fertilizer to some areas, Install new nets at Pool tennis courts.

Bob Gray asked about the possibility of renting the type of sideways mower, like the ones used by the city on the right of ways, to cut back the honeysuckle on the wood lines. Mitch thinks it might cost \$10,000 to \$15,000 but will investigate.

Mitch turned in his thirty day notice and Kate also turned in her resignation. The board accepted their resignations.

Asset Management Committee: Jake Bontatibus also mentioned the new mower.

Old Business: Bob Gray mentioned that he's been encouraged by Friends of Forest Ridge to have the Gazebo inspected and repaired. They may be able to help offset the cost of repairs.

The volunteer picnic is scheduled for August 10<sup>th</sup>. Jennifer Kelley agreed to be in charge of the event. Jennifer provided the board (via email) a list of known volunteers to be invited asking for help completing the list and getting email or street addresses.

All of the problem houses have been mowed. Dayton's Environmental Health Department will be inspecting 4519 Silver Oak in the near future. Sue Hanley has sent thank you notes to Dayton Mayor Whaley and to Riverside.

New Business: Chuck Evanhoe brought up the need for defined policies and procedures for Forest Ridge Operations, job descriptions and an Employee Manual/Handbook. He has talked with an HR consultant that has been supporting his company for several years. They will be putting together a list of documents needed from an HR perspective including health & safety issues. He also noted that the Pool has already begun the process of codifying its policies and procedures and a draft should be submitted to the board in the near future.

Forest Ridge board members will be walking the neighborhood to let residents know about the need to remediate broken and upheaved sidewalks.

Jake Bontatibus discussed that the eroding aqueduct needs replacement. It would cost approximately \$8,000 to get fixed.

Adjournment: Sue Hanley moved the meeting be adjourned and Jake Bontatibus seconded.

#### Vote 6-0

The meeting ended at 8:15 p.m.

# From The OHIO BMV Motor **Scooter Information**

REMINDER OF OHIO'S MOTOR SCOOTER LAWS

Motor scooters and mini-motorcycles have become hot items among children and teenagers.

Parents, grandparents and other family members are spending their hard earned money to purchase scooters and mini-motorcycles - just to find out that most cannot be operated on Ohio's roads and their children - or grandchildren cannot legally operate the vehicle.

In Ohio, the motor scooters and mini-motorcycles cannot be legally operated on Ohio's roadways unless - they are titled, registered, covered by the proper insurance and the operator is at least 16 years old with a motorcycle license or endorsement on his or her driver license.

Most of the small electric and gas powered motor scooters, which are sold in sporting good stores and department stores, are not roadworthy, therefore cannot be titled or registered.

In order for the scooter or the mini-motorcycle to be considered roadworthy each must contain a seat, not more than three wheels in contact with the ground, contain the proper brake lights, turn signals, horn, rearview mirrors and headlights.

The county title office will then issue a title for your motor scooter or mini-motorcycle. The title will cost \$5.

After you purchase your title, you will need to register your vehicle. The annual registration costs \$28.50, plus a permissive tax if required and any new plate fees.

The motor scooter and mini-motorcycle will be issued a motorcycle plate, which will need to be attached to the vehicle.

Please make sure you have the proper insurance coverage on your motor scooter or mini-motorcycle, before registering your vehicle. The owner and the operator of the motor scooter or mini-motorcycle are subject to financial responsibility suspensions if the proper insurance is not maintained.

And finally, in order for the individual to legally operate the motor scooter or mini-motorcycle - he or she must be at least 16 years old and hold a valid driver license with a motorcycle endorsement or a motorcycle license. It is very important to know Ohio's road laws and signs before an individual attempts to operate a vehicle of any kind on Ohio's roadways. Licensed drivers have been tested on their knowledge and skills.

Please, know the law before you purchase a motor scooter or a minimotorcycle. Know where they may be operated and who can operate them. If you have questions you may contact the BMV at 614-752-7800 and you also need to check with your local jurisdiction before you make the purchase.

It's about your safety, your children's safety and other drivers' safety.

If your FRA assessments are current, then you may pick up your passes AT THE POOL NO EARLIER THAN THE SATURDAY BEFORE MEMORIAL DAY.

The following rules and regulations are for the protection and benefit of all members and their guests. These rules have been adopted to secure safe and sanitary operation of the swimming pool in accordance with the Ohio Sanitary Code. A copy is posted at the pool. ALL RULES WILL BE STRICTLY ENFORCED.

The Board of Trustees has empowered the Pool Committee, Pool Manager, or staff member in charge with the authority to expel from the premises and/or suspend pool privileges for an extended period of time for anyone who does not comply with these rules or the instructions of the Lifeguards, Pool Manager, or Pool Committee.

SWIMMING IS OPENTO ALL FRA MEMBERS IN GOOD STANDING, i.e. whose assessments are current, UNDER THE FOLLOWING GUIDELINES:

# **POOL SEASON:**

The Pool Season begins the Saturday before Memorial Day and ends on Labor Day. Due to staffing restrictions during the first few weeks and last few weeks of the season, the hours that the pool is open may be limited. Please check the bulletin board at the entrance to the pool for special hours of operation during these periods.

# **POOL OPERATIONS:**

The pool may be closed for maintenance, weather, health conditions, or other emergencies as determined by the Pool Committee, Pool Manager, staff member in charge, or by the Board of Trustees. In addition, the pool may be closed to general use for FRA sanctioned events, e.g. home swim meets, etc.

# **ADMISSION REQUIREMENTS:**

- 1. All members of the FRA in good standing, i.e. whose assessments are current, will be issued pool passes.
- 2. A valid pool pass must be presented for admission.
- 3. Pool passes will be available at the pool the first day of the swim season (the Saturday before Memorial Day). Members who have their passes from year may use them again. Please keep your passes from year to year.
- 4. Members must bring a photo ID to pick up pool passes.
- 5. Members who lose their passes will not be admitted to the pool. Replacement passes must be obtained from the FRA Secretary or Pool Manager at a cost of \$3.00 per pass.
- 6. Admission of non-resident members: Season guest passes are limited to house guests of FRA members in good standing and payment of the following:
  - \$50.00 for the first pass
  - \$30.00 for the second pass
  - \$25.00 for the third pass
  - \$20.00 for fourth pass

Season guest passes may be requested up to a maximum of four (4) per lot.

- 7. Monthly guest passes will be issued by the FRA Secretary to house guests of a member in good standing for a payment of \$25.00 per month.
- 8. Weekly guest passes will be issued by the FRA Secretary or Pool Manager to guests of a member in good standing for a fee of \$10.00 per week per guest (maximum of 4 per week).
- 9. Each household has 10 free guest passes to begin each season. After these have been used daily guest passes will be issued to a guest accompanied by a FRA member in good standing for a fee of \$3.00 per person. Children 6 years

of age and under will be admitted for \$1.00. The pool management reserves the right to limit the number of guests permitted with a FRA member.

- 10. Full-time baby-sitters are treated as season guests and must pay the season guest rate.
- 11. A non-swimming adult guest will be admitted to the pool area in street clothes without payment of fee.
- 12. Non-members entering the pool on someone else's card will be asked to leave. The card will be held and turned over to the manager. The card will then be treated as a lost card. A fee of \$3.00 will be charged to get another card.
- 13. A charge of 25 cents will be imposed for re-lamination of pool passes.
- 14. Persons desiring exceptions to the above stipulations must refer their requests in writing for resolution by the Pool Committee and/or Board of Trustees to the FRA Secretary, P.O. Box 24750, Huber Heights, Ohio, 45424. Please include your lot number on all correspondence.

#### **GENERAL POOL RULES:**

- 1. Lifeguard duties do not extend to the wading pool.
- 2. Admission will be refused to anyone with skin abrasions, colds or coughs, inflamed eyes, infections, or wearing bandages.
- 3. NO GLASS CONTAINERS ARE ALLOWED IN THE POOL COMPLEX.
- 4. Eating is permitted ONLY in the patio area.
- 5. Beverages are allowed outside in the patio areas. Please make sure the empty containers are thrown in the proper receptacles
- 6. No ALCOHOLIC BEVERAGES ARE PERMITTED ON THE POOL PREMISES.
- 7. Smoking is permitted ONLY in the designated smoking area.
- 8. The FRA is not responsible for loss or damaged property.
- 9. Bikes are not allowed to be parked directly on the asphalt apron by the pool facility entrance. Bike racks have been provided and should be used to secure all bikes. The FRA is not responsible for thefts.
- 10. During periods of peak activity the Pool Manager or staff member in charge has the authority to limit the number of swimmers in the pool.
- 11. Flotation devices will be allowed at the manager's discretion.
- 12. Diving board use may be closed during open swim at the discretion of the Pool Manager, the staff member in charge, or the lifeguard responsible for the diving area.
- 13. All swimmers may be required to pass a basic swimming test at the discretion of the pool staff to determine if the swimmer may swim in water over his/her head.
- 14. A rest period may be required if fatigue or chill is observed.
- 15. Changes and exceptions to the pool rules may be made by the Pool Manager, the staff member in charge, the Pool Committee, or the Board of Trustees at any time without prior notice.

# **SAFETY RULES**

1. A discipline procedure will be followed for minor infractions of these rules as follows:

**1st offense:** warning

**2nd offense:** sit out for 20 minutes- the swimmer will either sit by the side of the pool or will be given the

option to leave for the rest of the day.

**3rd offense:** introduction of suspension policy

A serious infraction will result in immediate action by the Pool Manager or staff member in charge.

- 2. No running, pushing, wrestling or other disturbances are permitted in the pool or on the deck.
- 3. No horse play will be permitted in the diving bay. Front dives only off the diving board. Swimming is not permitted in the diving area unless the diving board has been closed to use.
- 4. Unsupervised games will not be permitted in the pool complex.
- 5. Abusive, offensive, or profane language will not be tolerated.
- 6. Lifeguards have the right to stop any unsafe or dangerous action taking place in the pool complex.
- 7. Fighting will not be tolerated in or around the pool area and will result in the immediate imposition of the suspension policy.

# SUSPENSION POLICY

**First time**: 3 day suspension

**Second time**: 5 day suspension, parent signature required for readmittance. 7 day suspension, parent signature required for readmittance.

**Fourth time:** Review by Pool Committee for seasonal suspension.

# POOL GROUNDS AND DRESSING ROOMS

- 1. No pets are allowed in the pool premises.
- 2. The destruction of pool equipment or property will result in suspension and/or expulsion from the pool and possible legal action.
- 3. Loitering is prohibited and anyone creating a disturbance or using inappropriate language will be asked to leave the pool facilities.
- 4. Only swim attire may be worn as swimsuits for swimming. Cutoffs are not allowed.

#### **GENERAL SWIMMING:**

- All children 7 years of age and under must be accompanied by their guardian or by any person 13 years or older with permission of the guardian. THE FIRST DAY THE CHILD COMES SWIMMING, HIS/HER GUARDIAN MUST ACCOMPANY THE CHILD TO GIVE VERBAL AND WRITTEN PERMISSION. This child's pass will be signed by the guardian, Including a phone number, to indicate to the desk person on duty that the child has the guardian's permission to come to the pool when accompanied by any person 13 years or older.
- 2. Children 8 through 12 years of age may come swimming alone provided permission has been granted by their guardian. Without permission to come alone, the child must be accompanied by any person 13 years of age or older. THE FIRST DAY THE CHILD COMES SWIMMING, HIS/HER GUARDIAN MUST ACCOMPANY THE CHILD TO GIVE VERBAL AND WRITTEN PERMISSION. If the child is allowed to come alone, his/her pass will be signed by the guardian, to include a phone number, to indicate to the desk person that the child may come the pool without being accompanied.
- 3. Any person 13 years of age or older may come to the pool alone without a signed pass.

# WADING POOL:

- 1. ONLY CHILDREN 6 YEARS OF AGE OR YOUNGER MAY USE THE WADING POOL.
- 2. Children using the wading pool must be accompanied, within the wading pool premises, by their guardian or any person 13 years of age or older AT ALL TIMES.

# **ADULT SWIMMING:**

- 1. Adult swimming is open to all persons 18 years of age or older.
- 2. During normal operating hours, an adult swim will be called 15 minutes before the hour and will last 15 minutes, except for the last hour of normal pool operation. One child, 6 years of age or younger, may be taken into the pool at this time when accompanied by an adult.
- 3. During Saturday morning Adult Swim and the Wednesday evening Adult Swim, no children will be allowed to be in the pool complex or to use the pool facility.
- 4. NO CHILDREN ARE ALLOWED IN THE LAP POOL DURING ADULT SWIM.

# LAP POOL:

- 1. The lap pool will always have at least 2 lanes open for lap swimming.
- The primary purpose of the lap pool is to swim laps. However, during peak times the lap pool may be opened for general use at the discretion of the Pool Manager or staff member in charge. During these times, lanes will be available for lap swimming.
- 3. After 4 P.M., adults desiring to swim laps will receive preference in the use of the lap pool.
- 4. Lap pool use may be modified at the discretion of the Pool Manager or staff member in charge.

# PARTIES:

- 1. FRA members may schedule special parties at the pool upon written request to the Pool Manager. A fee of \$60.00 per hour for parties with 25 people or less; \$70.00 per hour for parties with 26 to 50 people; and \$80.00 per hour for parties with 50 to 100 people, and \$90.00 per hour for parties of 101 people or more will be charged.
- 2. A minimum of two hours must be scheduled for each party. A \$60.00 deposit is required to hold a particular date. The remainder of the fee is due by the beginning of the party.
- 3. Cancellation notice must be received 3 days in advance for a full refund. A cancellation within 3 days before the party may result in \$30.00 of the deposit being forfeited.
- 4. Parties are scheduled after normal operating hours and may not continue after midnight.
- Food and drink are allowed WITH THE EXCEPTION OF ALCOHOLIC BEVERAGES.
   The FRA may cancel any party due to bad weather or other reason (see pool operations and hours). The deposit may be refunded.

#### PROPOSED SWIM LESSONS PROGRAM AND SCHEDULE

Program Coordinator: Pool Manager or their assignee

Classes will cost \$35.00 for FRA residents, and \$45 for residents of adjacent plats, \$40 for each additional family member. There must be a minimum of 6 students per class and a maximum of 8 students per class.

REGISTRATION FOR EACH SESSION WILL START THE WEDNESDAY AT NOON BEFORE THE SESSION BEGINS.

CANCELLATION OF CLASSES: Classes may be cancelled when less than 6 people sign up for the class.

REFUNDS: Refunds will not be given after the second day of class. If a refund is to be made, a refund card must be completed and signed by the Pool Manager. The card will forwarded to the FRA and a check mailed to you. Missed classes are not made up.

Swim lessons are two weeks in duration beginning at 11:00 AM. If lessons are cancelled the swimmer will be notified of any make up classes.

# **RULES DURING SWIM LESSONS**

- 1. The wading pool will be closed during swimming lessons.
- 2. Only one person per child is allowed to accompany the child in the water during lessons. All other people must remain in the patio area.
- 3. The pool is open in the morning for swim lessons only.

# PRIVATE LESSONS:

- THE LESSONS SHOULD BE ARRANGED THROUGH THE SWIM PROGRAM COORDINATOR.
- 2. A time and instructor will be assigned when you register.
- 3. Private lessons must be cancelled by calling the instructor or Pool Manager at least 24 hours in advance or a full class fee will be charged.

CLASSES OFFERED AND DESCRIPTIONS:
Beginner • Intermediate • Advanced

Instructors, at their discretion, may move children into other classes if they feel the child is in the wrong class.


