Board of Trustees Regular Meeting
May 16, 2016**

Trustees Present: Jennifer Kelley, Jesse Morgan, Jake Bontatibus, Lacey Soriero, Sue Hanley and Carol Wallace

Trustees Absent: Shelton Monger, Greg Herman, and Maria Ford

Jennifer Kelley called the meeting to order at 7:36 p.m.

Police Report: Officer Reeb from the Dayton Police Department was present to report 10 property crimes and no violent crimes. He said there were also no disorderly conduct crimes. Overall we are down to 12 from 17 total crimes since the last month. He also said over the last month they made 20 traffic stops in Forest Ridge and they cited 15 people. He said there is going to post a speed sign at Gander Road West within the next week. He also reported that they will continue to monitor stop sign running and speeding in the area.

Carol Wallace mentioned that as the weather improves and school lets out, people should expect more criminal activity. Officer Reeb said that they could implement a curfew sweep in the area to ensure juveniles are in by 9pm.

Sue Hanley discussed the report from the Riverside Police Department. She said they are short of police staff. She said the board wrote a recommendation for Sgt. Colon for a leadership position in the Riverside Police Department for which he has applied.

Visitors: Krystyn Funner was present to discuss the possible playground grant. Roberta Havholm was present to discuss the Murmurs. Chris Hummer was also present.

Minutes: Jennifer Kelley moved that the April 18, 2016 meeting minutes be accepted as corrected. Carol Wallace seconded.

Vote 6-0

Treasurer: Dan Freeman, Treasurer, reported that the General Fund balance is \$176,332.19. Replacement reserve balance is \$77,795.58. We received 41 full and 2 partial assessments (\$9,234.00) in April, and we've received 28 full so far this month (\$6,272.00); so there are 91 full and 3 partial assessments still open (\$20,669.00). This compares to 107 assessments (\$23,297.00) still open at the same time in 2015.

Jake Bontatibus moved that the May 16, 2016 Treasurer's report be accepted as submitted. Jesse Morgan seconded.

Vote 6-0

Murmurs: Roberta Havholm discussed the Murmurs. The theme will be Pool Opening. The pertinent articles will include Pool Rules, Graduates, and Pool Calendar. It will be delivered the weekend of June 4. It will be printed on white colored paper with a full color cover.

Chris Hummer asked about the capability for opting out of Murmurs paper delivery. Roberta said that pricing could possibly be cheaper for printing, but it would have to be a significant drop. About 500 people would have to opt-out for a significant price change

Jesse Morgan said that he would be willing to draft a poll for Nextdoor to ask for opinions on opting in/out of the paper Murmurs.

Communications: Jennifer Kelley said she has delivered four welcome packets and has one to deliver.

Website: No report.

Pool: Ellie Monger said that they have been busy working on maintenance and preparing for the opening of the pool. They have been working on tiling around the pool, and said that a permanent fix would need to be applied in the Fall.

Lacey Soriero said that she has done research on painting a mural on the baby pool. She said that there is not enough time to get the mural done before the pool opening, so they would need to prepare for doing the mural possibly next year.

Activities Committee: Jake Bontatibus discussed the upcoming garage sale and the advertising. He also discussed the food truck rally that is scheduled for May 28 and said that there are 3 trucks confirmed and up to 4 additional trucks may attend. Jake discussed putting together a community party on the Fourth of July. The board suggested having such a party on Labor Day weekend.

Jake discussed having a graduate party. The board said that a graduation party would likely be difficult due to timing of other events and graduation parties.

Pool and Outdoor Recreation Committee: Jesse Morgan said that they had 86 kids in the soccer program this year, and that the season went well.

Nothing additional from the Pool.

Green Areas: Chris Tooley, Green Area Manager, submitted the following report: Projects this month: Fixed batwing mower, fixed John Deere mower, fixed push mower, and fixed wood chopper.

Property: Edged flower beds in boulevard, started spraying for weeds, finished monument, re-edged sidewalks, started woods line against residential side, addressed light pole, replaced 5 swings, replaced 4 posts on pool fence, fixed hinges at pool gate.

To Do: Finish spraying weeds, start 3rd application of fertilizer, need to purchase 2 baby swings

Asset Management Committee: Jennifer discussed the activities of the committee over the past month. She said they have been working on replacing missing swings. She said they also did a walk through and have created a report that will be published in the Murmurs and online.

Sue provided a quote from Copeland to fix the shingles on the sign for \$85.00. The board agreed to proceed with the repair

Carol Wallace will be contacting Miller Dodson to get a quote for a capital reserve study.

Old Business:

Green Area Volunteers – Mr. Schaub was scheduled to attend and discuss the fence painting, but could not attend due to an emergency.

Checking account for swim team: The swim team will not be offering online processing this year, so the checking account is not necessary.

Grant Writing: Krystyn Funner received a quote for a modular playground equipment set from GameTime. She said that the salesman said that residents could install themselves. She said the grant application is due on May 31 by 4:30pm. The group discussed the application and what information was left to fill out.

Copeland Repair: Sue Hanley said Copeland has offered to repair the roof on the small building near the pool for no charge.

Carol Wallace made a motion to accept Copeland's offer to repair the roof. Jake Bontatibus seconded.

Equipment: Jesse Morgan made a motion to purchase a mower from Champion in the amount not to exceed \$11,500. Sue Hanley seconded.

Vote 6-0

New Business:

Bob Gray's memorial ceremony is scheduled for next Monday May 23rd at 7pm at the gazebo

Neighborhood Watch: Jennifer said that Maria wanted to discuss starting the neighborhood watch program again, but since Maria was not at the meeting she decided to table the discussion to next month.

Adjournment: Sue Hanley moved that the meeting be adjourned. Carol Wallace seconded.

June 20, 2016**

Trustees Absent: None

Jennifer Kelley called the meeting to order at 7:36 p.m.

Police Report: Officers Reeb and Conrads from the Dayton Police Department were present to report on six calls over the past month, which is a significant decrease in activity from the previous month.

He also reported on stop sign running and speed monitoring that they have been doing. He also discussed a search that was conducted at a resident's home due to drug activity as well as the ongoing work with resolving drug problems in the area. Jake Bontatibus asked about what is done to get back beyond merely the dealer. The officers described the work that is put into the drug problem and described some of the processes and examples of what they are doing to get back beyond the corner dealer to even the cartels. Sue asked that the officers ask Sgt. Colon for the monthly report that Riverside provides to see if would help with the report from Dayton. Officer Reeb discussed the City of Dayton crime map and said he would bring one next month.

Visitors: Rick Schaub, Krystyn Funner, Scott Huddle, and Terry Chandler

Minutes: Sue Hanley moved that the May 16, 2016 meeting minutes be accepted as corrected. Maria Ford seconded.

Vote 9-0

Treasurer: Dan Freeman, Treasurer, reported that the General Fund balance is \$172,099.20. Replacement reserve balance is \$77,797.34. We received 43 full and 2 partial assessments (\$9,782.00) in June, and we've received 20 full and 2 partials so far this month (\$4,764.00); so there are 55 full and 4 partial assessments still open (\$12,654.00). This compares to 69 assessments (\$14,510.00) still open at the same time in 2015. Maria Ford moved that the June 20, 2016 Treasurer's report be accepted as submitted. Carol Wallace seconded.

Vote 9-0

Murmurs: Roberta Havholm said there will be no Murmurs in July.

Communications: Jennifer Kelley said she has delivered ten welcome packets and said she noticed a lot of homes for sale so she will have several to deliver.

Website: Greg Herman reported on the websites. He reported that 627 neighbors had signed up for nextdoor.com. The Forest Ridge Facebook page had 1078 likes. Jennifer Kelley made a suggestion about putting something in the Murmurs to discuss the topic of responsible posting. Sue Hanley also suggested that Greg Herman post something on the nextdoor.com site about it.

Rick Schaub suggested that someone other than a board member should manage the nextdoor.com website. All of the board disagreed with the comment and Shelton Monger said that he disagrees with Mr. Schaub and said that Greg is neutral and leaves many posts that should probably be removed. Mr. Monger expressed his concern and disgust with many comments that are placed in the social media forums.

Pool: Ellie Monger was present and reported on the Pool. She said that the new printer is running and there haven't been any more problems. She said the pool has had a lot of activity due to the hot weather. She said Chris and the Green Area crew have been helping with the mowing and she expressed her appreciation. She also discussed a recent issue with the baby pool.

She said they have received several compliments about the pool area and the guards. Finally, she said she has a mural being painted by a young lady that needs service hours and she is doing a good job.

Activities Committee: Jake Bontatibus discussed the food truck rally and said that it was successful and that the vendors were impressed with the area, particularly with the young people and their use of manners.

Jake discussed having a Labor Day party with the possibility of a pit barbeque/pig roast. He said he got some quotes in the \$450 to \$600 range just for the pig. He said he would need about \$1,000 to hold the party to include table rentals.

Jennifer Kelley asked if Jake could put together a list of items that he would be need. Jennifer said they would table this until the July meeting.

Pool and Outdoor Recreation Committee: Shelton Monger reported on some issues that they have been working on since the opening including replacing a motor, fixing the baby pool, and fixing the chlorinator.

He also discussed the tile patching and is looking to get the work completed in the Fall. Finally, he said that he offered the profits from the candy sales toward the PA system since it was more expensive than expected and the Swim Team had originally offered to purchase the entire thing.

Jesse Morgan said the soccer season is over and they had a great season.

Green Areas: Chris Tooley, Green Area Manager, submitted the following report:

Projects this month: Regular maintenance on Equipment i.e. blades and oil changes, and fixed large tank sprayer

Property: Finished spraying weeds, applied 3rd application of fertilizer, prepped pool for opening, prepped for food truck rally, more woods line, wood chips along Blvd., edge sidewalks, replaced 2 basketball nets at pool, started mowing inside the pool

To Do: Re-adjust gate at pool, more woods lines, replace 2 baby swings

Chris expressed some concerns with last minute requests.

Chris formally announced that Mike Fry is the Assistant Green Areas Manager.

Lacey Soriero expressed her appreciate for Chris and his team's hard work in keeping the Green Areas looking nice.

Jesse Morgan asked Chris about work that needs to be done on the soccer fields. Chris said that work would need to be performed at the same time as the season is in progress. The group discussed the possibility of creating another field or using another field.

Asset Management Committee: Jennifer Kelley said that she is meeting with the Asset Management committee soon. She asked Carol about the research she has been doing on the reserve study. She asked that the board review the form she is working on to receive proposals by the July 4, 2016.

She also said that if any residents have issues with Green Areas, they should contact Jennifer directly and not the Green Area workers.

Old business:

Grant Writing: Krystyn Funner said that they turned in their application and they should receive word back from the City by June 30, 2016. She also said that Champion is going to donate the playground mulch.

Copeland Repair: Sue Hanley said that they would be putting a note in the Murmurs for the repair that was done. She also suggested some flowers/grass along the perimeter of building

Jennifer Kelley said the Bob Gray Memorial ceremony went well and was a success and she was very pleased with the turnout.

New Business:

Jennifer Kelley discussed the issue with corporation status. She received the following statement from the Association's lawyer:

"Once reinstated, the Ohio Nonprofit Corporation Act provides that the reinstatement is retroactive back to the date of cancellation and is as if the cancellation never happened. See Ohio Revised Code Section 1702.60: <http://codes.ohio.gov/orc/1702.60v1>. In the meantime, a nonprofit group is permitted by law to be unincorporated. It doesn't mean the group does not exist – just that they are not incorporated (unless reinstatement is made). Cancellation certainly doesn't mean that homeowners don't have to pay their association dues/fees!"

Jennifer also said that official communication from the board should and will be on the website and Murmurs and that official business items will not be posted on nextdoor.com. No board representation will post official information or business items on nextdoor.com or Facebook.

Shelton Monger made a motion to close discussion on the topic and Maria Ford seconded.

Vote 9-0

Jake Bontatibus suggested creating a 501(c)(3) charity for the sporting activities that could assist with fundraising for things like the swim and soccer teams. The board agreed it was worth looking into. Carol Wallace asked that Jake make a detailed suggestion/proposal sent via email. Jake said he would send one.

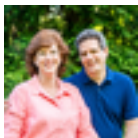

2016 Forest Ridge Pool Rules

Introduction

The Forest Ridge Association (FRA) Pool is a neighborhood pool owned and operated by the Forest Ridge Association for the enjoyment and benefit of the FRA members.

To ensure the safety and maximize the benefit to the FRA members, the following Rules, Procedures and Policies have been established by the FRA Board of Trustees to ensure compliance to all applicable laws, regulations and best practices. The controlling law is the Ohio Administrative Code (found in Appendix A) as enforced by the Montgomery County, Ohio Department of Health. Best practices are adopted as appropriate from sources such as the American Red Cross and the American Lifeguard Association.

Pool Rules

The following Pool Rules shall be published in the Forest Ridge Murmurs prior to and during each swim season so the all interested parties will understand how the FRA Pool will be operated:

**If your FRA assessments are current, then you may pick up your passes
AT THE POOL NO EARLIER THAN THE SATURDAY BEFORE MEMORIAL DAY.**

If you have your passes from last year they are still valid.

The following rules and regulations are for the protection and benefit of all members and their guests. These rules have been adopted to secure safe and sanitary operation of the swimming pool in accordance with the Ohio Sanitary Code. A copy is posted at the pool. ALL RULES WILL BE STRICTLY ENFORCED.

The Board of Trustees has empowered the Pool Committee, Pool Manager, or staff member in charge with the authority to expel from the premises and/or suspend pool privileges for an extended period of time for anyone who does not comply with these rules or the instructions of the Lifeguards, Pool Manager, or Pool Committee.

SWIMMING IS OPEN TO ALL FRA MEMBERS IN GOOD STANDING, i.e. whose assessments are current, UNDER THE FOLLOWING GUIDELINES:

POOL SEASON:

The Pool Season begins the Saturday before Memorial Day and ends on Labor Day. Due to staffing restrictions during the first few weeks and last few weeks of the season, the hours that the pool is open may be limited. Please check the bulletin board at the entrance to the pool, the Forest Ridge web site, or Facebook for special hours of operation during these periods.

POOL OPERATIONS:

The pool may be closed for maintenance, weather, health conditions, or other emergencies as determined by the Pool Committee, Pool Manager, staff member in charge, or by the Board of Trustees. In addition, the pool may be closed to general use for FRA sanctioned events, e.g. home swim meets, etc.

Hours of Operation are:

Monday – Sunday & Holidays.....12 PM – 8 PM

Saturday (Adult Swim)10 AM – 12 PM

Wednesday (Adult Swim).....8 PM- 9:30 PM

ADMISSION REQUIREMENTS:

1. All members of the FRA in good standing, i.e. whose assessments are current, will be issued pool passes.
2. A valid pool pass must be presented for admission.
3. Pool passes will be available at the pool the first day of the swim season (the Saturday before Memorial Day). Members who have their passes from the previous year may use them from year to year. Please keep your pool passes.
4. Members must bring a photo ID to pick up pool passes.

5. Members who lose their passes will not be admitted to the pool. A one time free replacement pass is available. Subsequent replacement passes must be obtained from the FRA Secretary or Pool Manager at a cost of \$3.00 per pass.
6. Admission of non-resident members: Season guest passes are limited to house guests of FRA members in good standing and payment of the following:
 - \$50.00 for the first pass
 - \$30.00 for the second pass
 - \$25.00 for the third pass
 - \$20.00 for fourth pass

Season guest passes may be requested up to a maximum of four (4) per lot.

7. Monthly guest passes will be issued by the FRA Secretary or pool manager to house guests of a member in good standing for a payment of \$25.00 per month.
8. Weekly guest passes will be issued by the FRA Secretary or Pool Manager to guests of a member in good standing for a fee of \$10.00 per week per guest (maximum of 4 per week).
9. Each household receives 10 free guest passes. After these passes have been used daily guest passes will be issued to a guest accompanied by a FRA member in good standing for a fee of \$3.00 per person. Children 6 years of age and under will be admitted for \$1.00. The pool management reserves the right to limit the number of guests permitted with a FRA member.
10. Full-time baby-sitters are treated as season guests and must pay the season guest rate of \$50.00 unless they do not swim.
11. A non-swimming adult guest will be admitted to the pool area in street clothes without payment of fee.
12. Non-members entering the pool on someone else's card will be asked to leave. The card will be held and turned over to the manager. The card will then be treated as a lost card. A fee of \$3.00 will be charged to get another card..
13. Persons desiring exceptions to the above stipulations must refer their requests in writing for resolution by the Pool Committee and/or Board of Trustees to the FRA Secretary, P.O. Box 24750, Huber Heights, Ohio, 45424. Please include your lot number on all correspondence.

GENERAL POOL RULES:

1. Lifeguard duties do not extend to the wading pool.
2. Admission will be refused to anyone with skin abrasions, colds or coughs, inflamed eyes, infections, or wearing bandages.
3. NO GLASS CONTAINERS ARE ALLOWED IN THE POOL COMPLEX.
4. Eating is permitted ONLY in the patio area.
5. Beverages are allowed outside in the patio areas. Please make sure the empty containers are thrown in the proper receptacles
6. No ALCOHOLIC BEVERAGES ARE PERMITTED ON THE POOL PREMISES.
7. Smoking is permitted ONLY in the designated smoking area.
8. The FRA is not responsible for loss or damaged property.
9. Bikes are not allowed to be parked directly on the asphalt apron by the pool facility entrance. Bike racks have been provided and should be used to secure all bikes. It is highly recommended that bikes be locked. The FRA is not responsible for thefts.
10. During periods of peak activity the Pool Manager or staff member in charge has the authority to limit the number of swimmers in the pool.
11. Flotation devices will be allowed at the manager's discretion.
12. Diving board use may be closed during open swim at the discretion of the Pool Manager, the staff member in charge, or the lifeguard responsible for the diving area.
13. All swimmers may be required to pass a basic swimming test at the discretion of the pool staff to determine if the swimmer may swim in water over his/her head.
14. A rest period may be required if fatigue or chill is observed.
15. Changes and exceptions to the pool rules may be made by the Pool Manager, the staff member in charge, the Pool Committee, or the Board of Trustees at any time without prior notice.

SAFETY RULES

1. A discipline procedure will be followed for minor infractions of these rules as follows:
 - 1st offense: warning
 - 2nd offense: sit out for 20 minutes- the swimmer will either sit by the side of the pool or will be given the option or to leave for the remainder of the day.
 - 3rd offense: introduction of suspension policy

A serious infraction will result in immediate action by the Pool Manager or staff member in charge.
2. No running, pushing, wrestling or other disturbances are permitted in the pool or on the deck.
3. No horseplay will be permitted in the diving bay. Front dives only off the diving board. Swimming

is not permitted in the diving area unless the diving board has been closed to use.

4. Unsupervised games will not be permitted in the pool complex.
5. Abusive, offensive, or profane language will not be tolerated.
6. Lifeguards have the right to stop any unsafe or dangerous action taking place in the pool complex.
7. Fighting will not be tolerated in or around the pool area and will result in the immediate imposition of the suspension policy. **SUSPENSION POLICY**
First time: 3 day suspension
Second time: 5 day suspension, parent signature required for re-admittance.
Third time: 7 day suspension, parent signature required for re-admittance.
Fourth time: Review by Pool Committee for seasonal suspension.

POOL GROUNDS AND DRESSING ROOMS

1. No pets are allowed in the pool premises.
2. The destruction of pool equipment or property will result in suspension and/or expulsion from the pool and possible legal action.
3. Loitering is prohibited and anyone creating a disturbance or using inappropriate language will be asked to leave the pool facilities. Anyone under the influence will be asked to leave the premises.
4. Only swim attire may be worn as swimsuits for swimming. Cutoffs are not allowed.

GENERAL SWIMMING:

1. All children 7 years of age and under must be accompanied by their guardian or by any person 13 years or older with permission of the guardian. **THE FIRST DAY THE CHILD COMES SWIMMING, HIS/HER GUARDIAN MUST ACCOMPANY THE CHILD TO GIVE VERBAL AND WRITTEN PERMISSION TO INCLUDE A PHONE NUMBER IN CASE OF EMERGENCY.** This child's pass will be signed by the guardian to indicate to the desk person on duty that the child has the guardian's permission to come to the pool when accompanied by any person 13 years or older.
2. Children 8 through 12 years of age may come swimming alone provided permission has been granted by their guardian. Without permission to come alone, the child must be accompanied by any person 13 years of age or older. **THE FIRST DAY THE CHILD COMES SWIMMING, HIS/HER GUARDIAN MUST ACCOMPANY THE CHILD TO GIVE VERBAL AND WRITTEN PERMISSION TO INCLUDE A PHONE NUMBER OF THE GUARDIAN..** If the child is allowed to come alone, his/her pass will be signed by the guardian to indicate to the desk person that the child may come the pool without being accompanied.
3. Any person 13 years of age or older may come to the pool alone without a signed pass and phone number of a parent or guardian.

WADING POOL: THERE IS NO LIFEGUARD ON DUTY IN WADING POOL AREA

1. **ONLY CHILDREN 6 YEARS OF AGE OR YOUNGER MAY USE THE WADING POOL.**
2. Children using the wading pool must be accompanied, within the wading pool premises, by their guardian or any person 13 years of age or older AT ALL TIMES.

ADULT SWIMMING:

1. Adult swimming is open to all persons 18 years of age or older.
2. During normal operating hours, an adult swim will be called 15 minutes before the hour and will last 15 minutes, except for the last hour of normal pool operation. One child, 6 years of age or younger, may be taken into the pool at this time when accompanied by an adult.
3. During Saturday morning Adult Swim time and Wednesday evening swim time no children will be allowed to be in the pool complex or to use the pool facility.
4. **NO CHILDREN ARE ALLOWED IN THE LAP POOL DURING ADULT SWIM.**

LAP POOL:

1. The lap pool will always have at least 2 lanes open for lap swimming.
2. The primary purpose of the lap pool is to swim laps. However, during peak times the lap pool may be opened for general use at the discretion of the Pool Manager or staff member in charge. During these times, lanes will be available for lap swimming.
3. After 4 P.M., adults desiring to swim laps will receive preference in the use of the lap pool.
4. Lap pool use may be modified at the discretion of the Pool Manager or staff member in charge.

PARTIES: Forms may be picked up in the pool office

1. FRA members may schedule special parties at the pool upon written request to the Pool Manager. A fee of \$65.00 per hour for parties with 25 people or less;

\$75.00 per hour for parties with 26 to 50 people; and \$85.00 per hour for parties with 50 to 100 people, and \$95.00 per hour for parties of 101 people or more will be charged.

2. A minimum of two hours must be scheduled for each party. A \$65.00 deposit is required to hold a particular date. The remainder of the fee is due by the beginning of the party.
3. Cancellation notice must be received 3 days in advance for a full refund. A cancellation within 3 days before the party may result in \$30.00 of the deposit being forfeited.
4. Parties are scheduled after normal operating hours and may not continue after midnight.
5. Food and drink are allowed WITH THE EXCEPTION OF ALCOHOLIC BEVERAGES.
The FRA may cancel any party due to bad weather or other reason (see pool operations and hours).
The deposit may be refunded.

PROPOSED SWIM LESSONS PROGRAM AND SCHEDULE Program

Coordinator: Pool Manager or his assignee

Classes will cost \$45.00 for Forest Ridge residents and \$40.00 for each child thereafter. \$50.00 for non-Forest Ridge residents and \$45.00 for each additional child. There must be a minimum of 6 students per class instructor and a maximum of 8 students per class.

REGISTRATION FOR EACH SESSION CAN BE MADE AT THE POOL OFFICE for each two week session.

CANCELLATION OF CLASSES: Classes may be cancelled when less than 6 people sign up for the class. All classes may be cancelled due to inclement weather. In such cases every effort will be made to contact the parents before class time.

REFUNDS: Refunds will not be given after the second day of class. If a refund is to be made, a refund card must be completed and signed by the Pool Manager. The card will be forwarded to the FRA and a check mailed to you. Missed classes are not made up.

Swim lessons are two weeks in duration. If lessons need to be cancelled the swimmer will be notified of any make up classes.

RULES DURING SWIM LESSONS

1. The wading pool will be closed during swimming lessons.
2. Only one person per child is allowed to accompany the child in the water during lessons. All other people must remain in the patio area.
3. The pool is open in the morning for swim lessons only.

PRIVATE LESSONS:

1. THE LESSONS SHOULD BE ARRANGED THROUGH THE SWIM PROGRAM COORDINATOR.
2. A time and instructor will be assigned when you register.
3. Private lessons must be cancelled by calling the instructor or Pool Manager at least 24 hours in advance or a full class fee will be charged.

CLASSES OFFERED AND DESCRIPTIONS:

Beginner, Intermediate, Advanced

Other classes may be offered upon sufficient demand and at the discretion of Program Coordinator.

Instructors, at their discretion, may move children into other classes if they feel the child is in the wrong class..

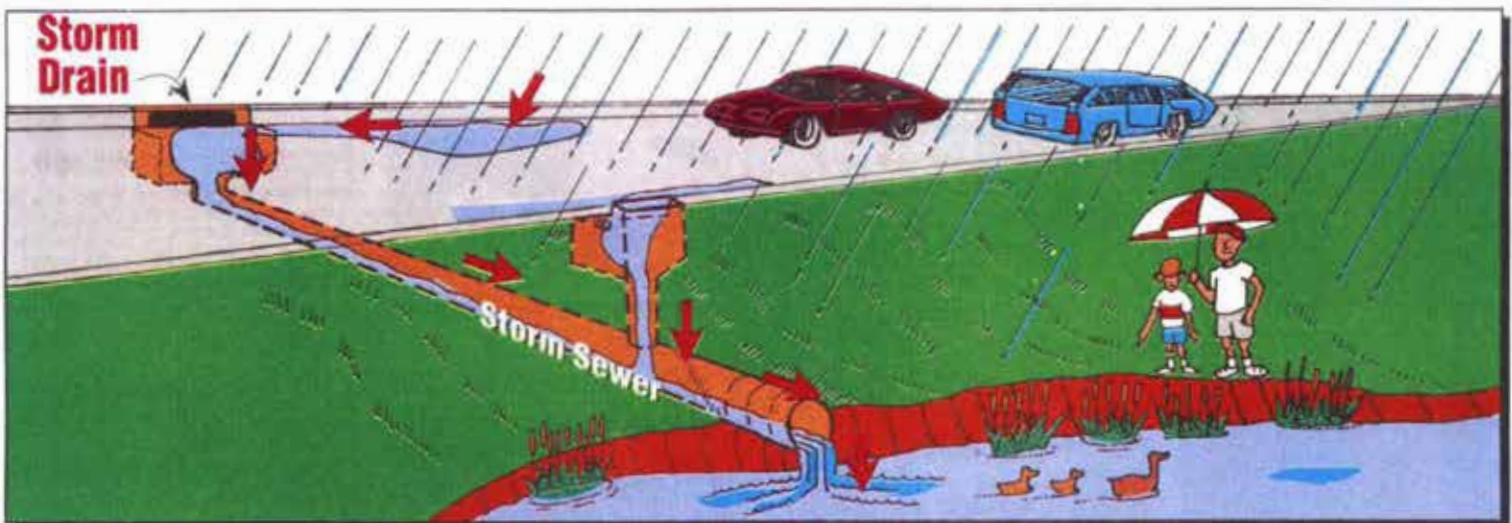
