Board of Trustees Regular Meeting
January 19, 2015

Trustees Present: Sue Hanley, Jake Bontatibus, Jennifer Kelley, Chuck Evanhoe, Roberta Havholm, Jesse Morgan, Greg Herman, and Shelton Monger

Trustees Absent: None

Sue Hanley called the meeting to order at 7:30 p.m.

Moment of Silence in memory of Bob Gray

New Trustee: Sue Hanley welcomed Jesse Morgan as a new Trustee to serve the remainder of Collin Monger's term which expires in 2016.

Election of President: Shelton Monger nominated Sue Hanley for President and Roberta Havholm seconded. Jake Bontatibus nominated Jennifer Kelley for President and Chuck Evanhoe seconded. Chuck moved that nominations be closed, and Jake Bontatibus seconded. The vote was taken via secret ballot which resulted in a tie. Sue Hanley removed herself from nominations and Jennifer Kelley was elected by acclamation.

Police Report: Officers Reeb, Williams, and Gundelfinger from the Dayton police were present to discuss the criminal activity in the area. They recommended not leaving cars running with the keys inside, as it is a ticket-able offense. No police from the Riverside Police were present.

Visitors: Bill Tocci was present to discuss the community garden.

Northeast Priority Board: No report.

Minutes: Roberta Havholm moved that the December 15, 2014 meeting minutes be accepted with corrections. Chuck Evanhoe seconded.

Vote 8-0

Treasurer: Dan Freeman, Treasurer, reported that the General Fund balance is \$8,299.38. Replacement reserve balance is \$49,794.40. We received one assessment (\$221.00) in December, and we've received none so far this month (\$0.00); so there are 53 full and 6 partial assessments still open (\$11,949.92). This compares to 56 assessments (\$11,526.00) still open at the same time in 2013.

Shelton moved to accept the Treasurer's report. Jake Bontatibus seconded.

Vote 8-0

Murmurs: Roberta Havholm reported on the February issue. The theme will be The Budget. The pertinent articles will include Budget, Soccer Information, and Fall Soccer Season Review. It will be delivered the first weekend of February. It will be printed on White paper with a full color cover. The article deadline is January 30, 2015.

Communications Committee Report: The board discussed how to handle the work that Bob was doing with the distribution of welcome packets. Dan Freeman said he would create a Google document that could be shared and contained the entire list of household addresses. The group could then note when they notice changes. Ellie Monger and Jake Bontatibus agreed to distribute packets to new residents.

Website: Greg Herman reported that there are 206 members on the Forest Ridge nextdoor.com website, and there are 914 likes on the Forest Ridge Facebook page.

Pool: Ellie Monger reported that there is only one guard not returning next season. She has notified guards that need to get recertified. She is putting together the schedule for swimming lessons and will give it to Sue for Facebook.

Pool and Outdoor Recreation Committee: Shelton Monger discussed the need to rebuild the platform in the pump room over the pits. He will be doing that in the spring.

Jesse Morgan said that he is starting preparations for spring soccer, and that advertising will begin in March. He said that they have all the needed equipment to begin the season.

Green Areas: Chris Tooley reported that he took out trash, picked up some parts, and put reflectors up. He also discontinued the trash service for the winter. He said he will likely start some work next month including tree work.

Asset Management Committee: Roberta Havholm said they have two quotes for the tree work. There are some issues with the quotes in that they did not quote the exact same work. The committee is going to contact both contractors to get the same work quoted for better comparison.

The gazebo roof is going to be replaced with shingles due to price. The committee is going to get three quotes for the work.

The Forest Ridge Sign needs some repair due to vandalism. The committee is looking at options.

Old Business: The semi-annual meeting is scheduled for March 2, 2015 at 7:30pm.

Jake Bontatibus discussed the cookie drive and said that it went well and that there were lots of goodies baked by residents that he delivered.

Bill Tocci discussed the status of the community garden. He said he is working on soil testing and how to get water to the garden area. He is going to set up a meeting with the green area committee in the next month and create a plan for the board to review.

New business: Sue Hanley moved to make a donation to the Greater Dayton Animal Society in the amount of \$100. Jake Bontatibus seconded.

The board discussed the need to replace the credit card for Chris. The board decided to get a prepaid Visa card for Chris to pay for things that cannot be paid on account.

The board discussed the need to appoint a new Trustee.

Adjournment: Chuck Evanhoe moved the meeting be adjourned and Shelton Monger seconded.

Attention Renters:

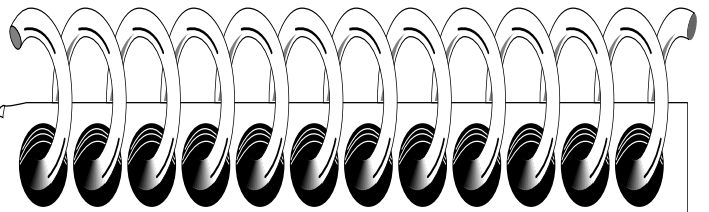

Call for Lifeguard Applications 2015 Season

The Forest Ridge Association is accepting applications for lifeguards and Recreation Supervisors for the 2015 season. Those interested must have current Lifeguard training, Standard First Aid, and CPR for the Professional Rescuer. Those with old Lifeguard Training will be required to update when the pool opens. WSI certification is recommended for consideration but not required for the available positions. Applications should be in résumé form and must include copies of the front and back of all certifications. The résumé should include any experience with young children, school, and community activities. Also include 2 written references from former employers, teachers, or community leaders. Previous employees of FRA do not need to submit references. The staff is responsible for helping with the opening of the pool and must be available to work on weekends during May (possible exceptions if away at school). You must also include your swimsuit and shirt size, date you can start full-time, all dates you must have off, and when you return to school.

Each year of experience means one season consisting of at least eight full weeks. For example, if an individual was hired prior to June 30 and works through Labor Day, the individual will be paid the next step the next year. If the individual is hired after July 1, the individual will be paid the same step for the entire next year. Prior experience at another pool, regardless of the number of years, will qualify the individual for a Step 2 if it can be verified that the individual has at least one full year of experience.

Residents of Forest Ridge receive preference for these positions, assuming they are otherwise qualified. WSI qualified applicants are preferred.

¹ Lifeguard certifications must be current at all times. It is the responsibility of each employee to provide such certification to the Recreation Area Manager. The base rate will be effective from the date the manager receives the certification, not retroactive to the date of the certification. If the Manager does not have a current lifeguard certification on file, the employee will be paid \$3.95/hour until such certification is provided.

² Current WSI certificates must be provided to the Recreation Area Manager in order to receive this rate. Once the WSI certification expires, the individual will be paid at the base rate until a current WSI certificate is again provided to the Recreation Area Manager. The WSI rate is effective on the date the Recreation Area Manager receives the current certificate, not retroactive to the effective date of the certificate.

Soccer Wrap Up

Our 2014 Fall Soccer Season was a success. This year for enrollment we had 52 kids spread across 6 teams and 3 age divisions. We also maintained 1 coach and assistant for each team (12 coaches and assistants total). For the first time, our league now includes concussion training for all of our coaches and referees.

Major erosion was threatening the new soccer bridge, but after a major effort by the board of trustees, a lasting solution has been found. This assures we will continue to have the bridge which is so critical to greatly improved safety, security, and accessibility of the soccer field.

We still have a long way to go in rebuilding this program. I would love to see enrollment at 100 kids, and 10 teams with more participation from all of the neighborhoods. 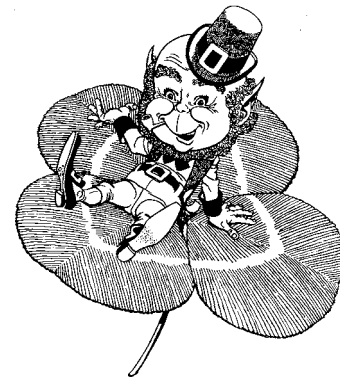
