Board of Trustees Regular Meeting  
March 18, 2019

Trustees Present: Heather Gwin, William Grant, Mike Bradley, Rich Spielman

Trustees Absent: Youssef Elzein, Chris Hoopes  
Heather Gwin called the meeting to order at 7:06 p.m.

Minutes: Heather Gwin moved to accept the February minutes as amended. Rich Spielman seconded.

Vote 4-0

Treasurer: Dan Freeman, Treasurer, absent. Heather Gwin provided an update:

The balance of the general fund is \$68,787.87. The balance of the replacement reserve is \$51,852.14. There were 259 full and no partial assessments received in February (\$76,774.98) and 486 full and 5 partials so far in March (\$129,751.80). There are 334 full and 4 partial assessment still open (\$89,417.74), compared to 207 full (\$42,506.00) in 2018. Extension of assessment fee deadline has pushed incoming fees to arrive later than normal. Financial report is tabled until Dan is available.

Police Report: An officer from the City of Dayton police was present to discuss criminal activity over the previous month but had nothing specific to report. Heather reported drag racing on Amberwood. Heather also spoke for Nick Toscani from the Riverside Police. The Virtual Block Watch program is still registering cameras, with over 30 registered already. There will be an alternate sign up option soon for those residents not on Facebook.

Communication: The committee has developed an Informational survey, with plans for it to go out in the April Murmurs, as well as all social media outlets and a direct mailing. The online via SurveyMonkey requires an annual fee of \$384 due to the number of questions and to allow for more responses.

Heather moved to approve funding for SurveyMonkey, Mike Bradley seconded

SignupGenius.com for activities is delayed; however, spring and summer activities will be posted in all outlets in the next few weeks to allow people to start planning.

Welcome packet letter is finished pending maps, with the whole packet to be finalized at next communications meeting in April.

Greens Areas: Chris Tooley, Green Area Manager, discussed the activity of the previous month. Recently they cut down trees along the boulevard, with pictures posted on NextDoor.

The crew recently picked up sticks, picked up trash along main streets, started cleanup along the wood lines, swamp, playground, etc. Re-rocked the driveway at the shop, rearranged equipment for upcoming use, cleaned and repaired woodchipper.

There was a discussion regarding firewood from tree cutting. Greens crew can move stuff near the road, but not farther off the beaten path. Discussion and decision tabled for a future session.

Upcoming: Tune-ups on equipment, mowing starts in April. First round of fertilizer purchased for April disbursement, soccer fields seeding in mid to late April. Another tree down in tree farm, plus multiple dead trees by gazebo.

Mike Bradley reported that the situation at the Trail Head area has been finalized. The Montgomery County Environmental Service has signed off on the current state. Much of the area was cleaned out; we won't be moving what is remaining but will be containing the area in the future. We now have documentation from the EPA that shows we are in compliance.

Assessment: Youssef Elzein absent, Bill Grant and Jake Bontatibus provided updates.

Youssef resigned at the last committee meeting. Currently, members are to identify the top 2 priorities in their areas for the next meeting. The Open House is planned for June, and the next committee meetings planned for March 24.

Activities/Recreation: Heather Gwin discussed the Easter Egg hunt that is scheduled for April 13. Signup.com will be available soon, with sign-ups for volunteers accepted through April 6<sup>th</sup>. Volunteers are needed to provide food and other goodies, as well as help on day.

Memorial Day Pool opening will have a food truck rally. The permit for the Garage sale on June 22<sup>nd</sup> is squared away, meaning individuals do not have to get permits to have a garage sale at their house.

Other summer activities, mostly pool based, include the Labor Day party, 4<sup>th</sup> of July party, and Doggie Swim. Fall activities are in process as well; the hay rides are planned, and Stebbins has already agreed to participate in our Halloween parade.

Give Back Thanks is planned for week of November 10-17; might try to do a community clean-up day. The Christmas Light Fight is being changed somewhat; the plan is to have preliminary judging to narrow down the finalists, with online voting for the community to choose the winners.

Pool: Rich Spielman let us know that all the Life guards are hired, and all 12 are from the Ridge. Updates to the website have been provided, as well as social media posts to come out in the next few weeks. A large informational layout will be in the March edition of the Murmurs.

SwimSafe is working on safety and compliance issues identified in December, as well as working on the pool house (power washing, painting and minor repairs). During a walkthrough of the pool area, a few additional problem items were found that need to be addressed before the pool opens, which include raising the cement around the wading pool, and replacing a previous patch job.

Soccer: Jesse Morgan said the upcoming season starts next week! Tuesday is first practice.

The relationship with Our Lady of the Rosary has provided a playing field; the players will be using St Adalbert Catholic Church. This location has multiple fields which is great for soccer parents.

No definite word on a replacement yet, but he's still working on it.

Mike Bradley introduced Josh Floyd, a potential new board member.

Open Questions: Jake asked if there was a way to cover the costs of the displays for the Assessment Open House. The Activities Committee can cover the costs.

Heather Gwin called to adjourn the general membership session, Rich Spielman seconded. Meeting adjourned at 7:43pm.

# FOREST RIDGE ASSOCIATION SWIMMING POOL INFORMATION

## ***Admittance***

- \* Everyone must have a pass or be an authorized guest.
- \* Admission may be refused based on health concerns observed by staff (illness, abrasions, bandages, etc).
- \* All swimmers under the age of 7 must be accompanied by a guardian or the guardian's designee who is 13 or older. To appoint a designee, the guardian must accompany the swimmer on the first trip to the pool to provide written permission and an emergency contact number.
- \* Children ages 8 - 12 may come swimming alone with written guardian permission. The guardian must accompany the swimmer on the first trip to the pool to provide written permission and an emergency contact number.
- \* During adult swim hours, only persons age 18 + will be admitted. No children of any age will be admitted.

## ***Pool Grounds Rules***

- \* FRA is not responsible for loss, theft or damage to property.
- \* No loitering. Anyone causing a disturbance will be asked to leave.
- \* Destruction of pool property will not be tolerated.
- \* No glass containers.
- \* No food in the pool.
- \* No alcoholic beverages.
- \* Please place trash in proper receptacles.
- \* No pets.
- \* No profanity.
- \* Smoking in designated areas only.
- \* Bikes must be parked in the bike rack area ONLY. Please lock up your bikes.
- \* No running, pushing, wrestling or rough-housing.
- \* No fighting - will result in immediate suspension.
- \* Staff may stop any unsafe action taking place.

Pool rules are for the protection and benefit of all members and guests and have been adopted to secure safe operation of the pool. The Board of Trustees has empowered the Pool Committee, Pool Management Company or staff member in charge with the authority to suspend or expel anyone who does not comply with rules or instruction of onsite staff.

**ALL RULES WILL BE STRICTLY ENFORCED**

## ***General Swimming Policies***

- \* Please wear proper swim attire.
- \* During periods of peak activity, staff may limit the number of swimmers in the pool.
- \* All swimmers may be required to pass a basic swim test at the discretion of staff in order to determine if swimmer is safe in water over his or her head.
- \* A rest period may be required if fatigue or chill is observed by the staff.
- \* Adult swim (18+) will occur 15 minutes before the hour and will last for 15 minutes, excluding the last hour of operations. An adult may bring one child age 6 or under into the L-shaped pool during this time.
- \* Diving board may be closed at staff discretion. Front dives only. No horseplay or swimming in the diving area.
- \* Flotation devices allowed at staff discretion.
- \* Wading Pool: ages 6 and under ONLY. Child must be accompanied by a guardian or person over 13 AT ALL TIMES. Lifeguard duties do not extend to the wading pool.
- \* Lap Pool: Two lanes will be open for laps at all times. During peak swimming times, pool may be opened for general use. After 4pm, adults swimming laps receive preference in use.

## ***Discipline Procedures***

- \* 1st Offense: Warning
- \* 2nd Offense: Sit out for 20 minutes
- \* 3rd Offense: Introduction of suspension policy
- \* First suspension: 3 days
- \* Second suspension: 5 days
- \* Third suspension: 7 days
- \* Fourth suspension: Review by pool committee for possible seasonal expulsion

In cases of serious infractions, the pool staff may escalate the discipline procedures as needed. Upon swimmer suspension, the parent/guardian signature will be required for suspended swimmer to return to the pool, once the penalty period has passed.

- \* Pool Opens - May 25th
- \* Independence Day Party - July 4th (12:00 to 5:00)  
Food, fun & games. No charge for guests.
- \* Pool Raft Party - August 10th (7:00 to 10:00)  
Food, fun & games. No charge for guests.
- \* Labor Day Party / Pool Movie Night - September 2nd  
Food, fun & games.
- \* Last Day of Swim Season - September 2nd
- \* Doggie Swim - September 3rd (6:00 to 8:00)

## **Private Parties**

- \* Scheduled by written request to pool manager
- \* Start after 8:00 pm and must end by midnight.
- \* 2 hour minimum duration.
- \* \$ 65.00 deposit to reserve date, balance due by the start of the party.
- \* Cancellation must be received 3 days in advance of the party for a full refund.
- \* FRA initiated cancellations will result in full refund.
- \* Fees will be on an hourly rate as follows:
  - < 25 people -- \$ 65 per hour
  - 26-50 people -- \$ 75 per hour
  - 51-100 people -- \$ 85 per hour
- \* Normal pool rules apply during parties.

---

The pool may have special operating hours at the beginning and/or end of the season due to lifeguard availability. These hours will be posted at the pool entrance in advance.

The pool may be closed for maintenance, weather or other emergencies as needed with or without advance warning. The pool may also be closed to general use for FRA sanctioned events, such as home swim meets. Swim meet dates will be posted in advance.

## **Swimming Lessons**

- \* Beginner, Intermediate and Advanced classes..
- \* Register at the pool. Registration closes one day prior to the swimming class session start date.
- \* Two sessions: June 17 - 28 & July 8 - 19
- \* Sessions are two weeks in duration with lessons in the morning Monday thru Friday.
- \* \$ 40.00 per session. No refunds given after the second day of the session
- \* Minimum of 6 and a maximum of 8 swimmers per class. Class may be cancelled without 6 participants.
- \* Instructors may move students into a more suitable class at their discretion.
- \* The pool will only be open for swimming lessons in the morning. No other swimmers will be allowed.
- \* Only one support person on pool deck per student.
- \* Private lessons are available, see pool manager.

## **Guest Passes**

- \* 10 free daily guest passes available per season.
- \* Daily guest fee \$ 3.00, \$ 1.00 for ages 6 & under.
- \* 1 non-swimming adult guest in street clothes is free.
- \* Pool manager may limit the number of guests admitted per member at one time.
- \* Weekly (\$ 10), monthly (\$ 25), and seasonal guest passes (see manager) are also available to house guests or baby sitters ONLY and are limited to 4 per lot.

# From The OHIO BMV Motor Scooter Information

## REMINDER OF OHIO'S MOTOR SCOOTER LAWS

Motor scooters and mini-motorcycles have become hot items among children and teenagers.

Parents, grandparents and other family members are spending their hard earned money to purchase scooters and mini-motorcycles – just to find out that most cannot be operated on Ohio's roads and their children - or grandchildren cannot legally operate the vehicle.

In Ohio, the motor scooters and mini-motorcycles cannot be legally operated on Ohio's roadways unless - they are titled, registered, covered by the proper insurance and the operator is at least 16 years old with a motorcycle license or endorsement on his or her driver license.

Most of the small electric and gas powered motor scooters, which are sold in sporting good stores and department stores, are not roadworthy, therefore cannot be titled or registered.

In order for the scooter or the mini-motorcycle to be considered roadworthy each must contain a seat, not more than three wheels in contact with the ground, contain the proper brake lights, turn signals, horn, rearview mirrors and headlights.

The motor scooter and mini-motorcycle will be issued a motorcycle plate, which will need to be attached to the vehicle.

Please make sure you have the proper insurance coverage on your motor scooter or mini-motorcycle, before registering your vehicle. The owner and the operator of the motor scooter or mini-motorcycle are subject to financial responsibility suspensions if the proper insurance is not maintained.

And finally, in order for the individual to legally operate the motor scooter or mini-motorcycle – he or she must be at least 16 years old and hold a valid driver license with a motorcycle endorsement or a motorcycle license. It is very important to know Ohio's road laws and signs before an individual attempts to operate a vehicle of any kind on Ohio's roadways. Licensed drivers have been tested on their knowledge and skills.

Please, know the law before you purchase a motor scooter or a mini-motorcycle. Know where they may be operated and who can operate them. If you have questions you may contact the BMV at 614-752-7800 and you also need to check with your local jurisdiction before you make the purchase.

It's about your safety, your children's safety and other drivers' safety.
