If they are not, we need to make sure that they are included in the next one. New Business:

Fall Member's Meeting Prep – Meeting will be held at the pool complex. Buying a screen and speakers. We will try do slides but might be too light outside for people to see them. Signs will be put out 2 weeks in advance. Notifications have been mailed and will also be posted on social media several times before meeting. We will post someone at the church to redirect people to the pool or place a sign at the Church.

Special Assessment vote for City of Riverside curb repair. Does the board want to pay the City of Riverside curb repair assessment of \$36,626.50 from unexpended 2020 Operational Funds versus doing a special assessment? Yea we want to use unexpended 2020 Operational Funds; Nay we want to use a special assessment. Mike Bradley moved that the board votes on it and Mike McHugh seconded the motion.

Vote - 9 Yea-0 Nay

Payment for curbs will be paid from 2020 unexpended Operational funds.

### Forest Ridge Association Board of Trustees Semi-Annual Meeting March 2, 2020

Mike Bradley called the meeting to order at 7:01 PM Minutes/Finance from previous semi-annual meeting: minutes were approved by the board and voted in Police Report:

Dayton: not present

Riverside: Officer Toscani was present. He is the community outreach officer. Generally, there are 50 calls for service in the Riverside portion of FRA. He spends any downtime he has during his duty day doing traffic stops. Most of the people he pulls over are FRA residents. Put out a reminder regarding scams that going around. Reminding people not to pay those people and contact the police if you have questions. They have created a Virtual Blockwatch for residents with cameras to assist with incidents that have happened in their vicinity. There are 40 members. The endangered lifesaver program for people with Alzheimer's, dementia or autism for assistance. They take a picture of the person for their records in case they go missing. They have had to use the system about 10 times, and they have found the person each time. Dayton residents are free to register for any of these programs. Contact Nick Toscani directly.

General Board Overview: We have hired Towne Properties to manage the FRA financials. The day to day operations are still handled by the board of trustees. Towne Properties is only responsible for bookkeeping and records storage. They have an online portal for looking at your account.

Hired Kaman and Cusimano LLC as the FRA legal team. They specialize in HOA law and helped to draft the Ohio law 5312. We have implemented a collection policy. Everyone should be paying their fair share. We have developed and implemented a path forward on reserve funding to be in compliance with Ohio law 5312 to maintain the FRA assets. This does not include the roads in the FRA.

We need to press forward with HOA management improvement. We are working to reduce overdue assessment rates through collections enforcement. We are looking to create an infrastructure Committee and oversee the reserve study projects. Update and simplify the by-laws and Restrictions/Covenants.

Current FRA Trustees are: Mike Bradley, President; Bill Grant, Vice-President; Rich Spielman, Treasurer and Larry Ford, member at large. We currently have 5 positions open. Committee Reports:

Treasurer: The operating budget covers the day to day operations of the Forest Ridge Association. It is required by our by-laws and is based on anticipated expenditures plus CPI and is currently \$253.03 of the total 2020 assessment which is \$12.63 less than last year.

The Reserve budget is new this year and is used to repair

or replace Forest Ridge Association property. It is required per Ohio law 5312 and we have based if on the 2017 reserve study that was completed and is currently \$86.73 of the total 2020 assessment and is new this year.

For our financial reporting in the past we were providing ending balances of the accounts, a comparison of current and prior year assessments and providing little if any detailed information. Starting this year Rich will be providing beginning & ending monthly balances of the accounts, show where the revenue came from, show what expenditures were for and detailed status of assessments. This will be presented at the board meetings and published in the Murmurs.

Communications:

We are currently in the process of reaching out to the webmaster for admin rights for website updates. Also, we are reaching out to current and former FRA volunteers for communications turn-over. We are creating a communications task and priority list along with a yearly schedule template. Maintenance and Green Areas:

Not much happens in the winter. Spring is upon us so you will start to see more things happening around the ridge. Lawn mowing will start in about a month. We have also received a donation of a tulip tree from Arbor Experts that needs to be planted. We are also working with Arbor Experts to have them come out for a day and remove as many dead trees as they can. A root ball was removed from a downed tree across from the shed. Leisure Lawn will be providing the application of fertilizer/weed killer this year as we do not have an employee with the necessary licenses to apply these chemicals. Colan Monaghan will be coming on as the Greens Maintenance Supervisor, he has worked for Forest Ridge for three years. He will need to get his chemical license. The Greens committee will be working with the Infrastructure committee to get some of these projects taken care of.

Three resignations: Heather Gwin, Youssef Elzein and Josh Floyd. Emily Nelson has been removed for absence by the board of trustees per Article VIII Sec 1.c. Nominees selected by Board of Trustees are: Tabitha Bentz (22), Scott Kreckman (22), Mike McHugh (20), Steve Weiser (20). Elected trustees will serve out unexpired terms of previous Trustee based on their "request to serve" date. The nominees introduced themselves. Welcome packets: Contact Maria Ford if you are a new resident and she will provide you with a welcome packet. Mike Bradley opened the floor for member questions Member Doug Benbow on Corkhill Drive wanted to thank this board and the two previous boards for bringing us into financial reality. Commented that the assessment fees have not been the correct amount for decades you people have stepped up to the plate and got us to where we needed to be. We have lived here since 1970, almost 50 years, we have always considered it a good place. Thank you for what you are doing. Mike Bradley stated that we as a board are trying to do the right thing for the community, sometimes that requires hard decisions. We had a lot of folks step up to help last year with the assessment committee. It was not just the board members coming up with this. That is what we need, we are here to make decisions with you not for you. If there are committees you feel you could help with please step up and help us out. We want your input. We want to make sure we have everyone's understanding and approval. We know we won't make everyone happy but if you're not happy let us know. Member Brad Ashmore from 5409 Splitrock stated that he has had several incidents with his neighbors that are renters, including his dog being shot. He wants to know how the bylaws can be changed to ensure that renters are being held accountable and that the neighborhood doesn't have deadbeat landlords. Mike Bradley stated he was sorry the residents were going through this. There have been conversations with the attorneys regarding having the by-laws changed and potentially limiting how many renters we are allowed to have in the neighborhood. While we can't make any changes to city or county ordinances as that's out of our control, but we can look at some rules changes. Landlords and tenants have rights, so we need to ensure we follow what the lawyers suggest and go from there. Resident also mentioned that every time he has to file a police report for property damage or instances with the neighbors that affects the crime rates in the neighborhood. This can also affect insurance rates. When the by-laws committee is formed please step up and help us. Member Sue Hanley on Quail Bush Drive had a question regarding why the late fee wasn't instituted until a month after it was supposedly due. In past years if your assessment wasn't to whomever was collecting it by the 28th or the 29th your late fee was immediately added. Right now, you have lost whatever the late fee is for the 400 and some houses that haven't paid. Mike Bradley said

that was a good question, that was on recommendation on the attorney on how the fees structures should go on late payments. It also gives time for any processing to get done, what we didn't want to see was someone paying at the last minute and it not getting updated and they being assessed a late fee when they shouldn't have been. Sue is concerned that a lot of people might be confused as to why should I worry about paying when I won't be getting a late fee until the end of March. The board feels it is more lucrative to go after the 29 houses that owe \$65,000 then worry about a few neighbors who might not have quite made it on time for the 29<sup>th</sup>. We are going after people who haven't paid in 20 or 30 years. Yes we want everyone to pay their fees. We will go back and take a look at that and reassess with the attorneys if we feel that is necessary. A member asked whether we could figure out on the past due accounts who still lives in Forest Ridge and how many have actually moved out. Mike Bradley stated that if the members have previously moved out and no liens were filed, we are out those fees. The \$65K that is currently on the books is owed by people who are still living in the neighborhood. He can guarantee that there is money that has been lost over the years because we did not have a lien filed. Mike reiterated that when he signed up to be on the board and more importantly the board president that he wanted this to be one of his main priorities. Everyone should be paying their fair share. Member Dennis Iones wants to know how many of these 29 homes are occupied by the homeowners and not renters. Mike stated that he knows there are many that are owner occupied but many others are being managed by property management companies. That does not stop the FRA from going after those funds. We are watching, with the help of the attorneys, the properties that have had their tax liens sold to other companies so that we are sure that we are inline for the monies that we are owed. A member asked what the timeline is for replacing the Forest Ridge sign that is on Kitridge and Strathaven. Mike Bradley stated that he filed a claim against the insurance and played phone tag with the insurance agent for about 3 weeks. Unfortunately, when we lost some board members that task fell to the wayside. He is hoping that now that we are back up to 8 that that task will get completed quickly. Member Heather Gwin wanted to make sure everyone is aware that Forest Ridge Blvd and Meadowsweet will be being repayed starting the May/June timeframe. A member wanted to know if they were required to register for an online account with Towne Properties. Mike Bradley stated no it is not required per se; however, it does afford you the opportunity to have a real-time view of your account. A member wanted to know how they will get pool passes since the form was not included with the bill as it normally is. Mike Bradley stated that yes that was overlooked this vear. You can always just go down to the pool to get your passes. The pool has a list of current property owners, also last year's passes will continue to work this year. Mike Bradley asked everyone to please vote on the way out the door. See you in September. Mike Bradley adjourned the meeting at 8:33.

# **Voting Results**

Fellow FRA Members,

I'm pleased to announce the voting results from the Fall Member's Meeting, held on September 14, 2020, for the four Trustee position elections and the waiver of the Reserve funding for 2021. We did make quorum for the meeting so the elected Trustees will be able to serve a full 3 year term. Trustees: Jesse Morgan - 106 votes, Justin Hickman - 102 votes, Scott Kreckman - 98 votes and Steve Weiser - 96 votes.

2021 Reserve funding: 19 of 1123 (2%) eligible Members voted to waive funding the Reserve account in 2021. Ohio Law 5312 requires 51% or more of the Members to approve waiving, so the Reserve Fund will be funded next year according to the amount called for in the 2017 Reserve Study plus CPI.

I want to thank everyone who took the time to vote even though it was just over 10% of the eligible FRA Members (122 of 1108). I also want to thank the four Trustees who agreed to donate their time to serve the Forest Ridge community!

Hopefully we will be able to see you all at the March 2021 Spring Member's Meeting!

(Expenditures are a lot lower than expected due to not being able to hire a full-time green area supervisor, and Covid-19 which resulted in a shorter pool season and the cancellation of most of our activities. We will also be getting back \$ 17,400 from Swimsafe because of the shortened pool season.

(These excess 2020 funds will be used to (1) pay the City of Riverside \$36,600 for the cost of the curb and storm drain replacement, (2) take care of capital improvement projects this year and (3), transfer any remiaing funds to the reserve funds account to accomplish projects next year.)

### STATUS OF UNCOLLECTED FRA ASSESSMENTS


Prior Year Uncollected Assessments. At the end of 2019, we had 118 properties that owed \$ 86,388. We have collected \$ 35,288 from 70 of these properties and have written off around \$ 6,000 as uncollectable. Forty-six properties still owe \$ 44,518. The new collection policy is paying off.

Total Uncollected Assessments as of August 31, 2020. Ninety-seven properties owe \$ 85,793. Forty-six properties owe \$ 73,790 (\$ 44,518 for prior years and \$ 28,272 for current year). Fifty-one properties owe \$ 12,003 for current year assessments. We have liens on 41 properties (\$ 61,674).



# A Sign of Trouble

With the fast approaching elections in November, the Board would like to remind everyone of the sign policy for FRA owned properties. This includes the center median along Forest Ridge Boulevard.

#### FOREST RIDGE ASSOCIATION RULE #19-001

**Temporary Signs** 

To halt the proliferation of temporary signs on Forest Ridge Association (FRA) property, the Board of Trustees hereby prohibits the placement of temporary or permanent signs of any type, except as outlined below:

- 1. Signs related to Forest Ridge Association official business or sponsored events.
- 2. Signs that the Board President or designee determines are of importance to or that serve the greater good of the Forest Ridge community as a whole. Sign owners must receive permission each time a sign is requested to be posted.
- 3. All temporary signs can be displayed for a maximum of thirty (30) days and must be removed no later than 48 hours after an event.
- 4. All ordinances regulating signage must be followed for the city in which the sign is placed.

Examples of prohibited temporary signs include but are not limited to political signs, real estate signs, placards, and various advertisements and only apply to signs placed on property owned by the Forest Ridge Association. Homeowners may place signs at their discretion on their own private property.

The Greens Maintenance crews will remove and dispose of any signs located on FRA property, which includes the median along Forest Ridge Boulevard. Sign removal will occur during the crews' routine work assignments in the neighborhood. Removed signs will be held at the maintenance shed for five (5) days for owners to claim. All unclaimed signs will be disposed of after the 5 days. This policy shall remain in effect until rescinded.
