FAIRBORN SCHOOLS STARTING LATER THIS YEAR DUE TO CONSTRUCTION DELAYS

Fairborn City Schools has moved back the start of classes districtwide due to construction delays at one building.

The district announced this week classes for grades 1-12 will begin Sept. 6 after delays in school construction timelines at the new multimillion-dollar Fairborn Intermediate School.

The first day for staff will now be Aug. 30 and the first day of classes for PreK-K students will be Sept. 9, according to the district's announcement.

Due to the delay in the start of the school year, the district said the school days will be longer to ensure the district gets enough instruction time as required by the state.

Fairborn Primary 8:49 a.m. to 3:25 p.m.

Fairborn Intermediate 8:05 a.m. to 2:46 p.m.

Baker Middle School 7:40 a.m. to 3:01 p.m.

It outlines how to create an online account with Associa, and also your payment options. Payment fees are only if you are going to be paying your assessment online. If you are mailing a check, there is no extra fee.

I created an account and it took less than 3 minutes.

The following information is intended to help familiarize you with the services and resources that are available to you. If you have any questions regarding the information provided in this letter, please contact Associa, Community Management Solutions (contact information listed below).

- 1. TOWNSQ: The Association will utilize the TownSq app as a platform for owners to obtain copies of the Association's documents and forms, to view unit information such as account balance and payment history, and to make online payments. New users will need to register from a desktop or laptop computer using the Chrome, Safari, or Firefox web browser. Please note that TownSq is not compatible with the Internet Explorer web browser, as it is no longer supported by Microsoft. TownSq can be accessed via the internet at https://app.townsq.io or on most smart phones by downloading the app after you are registered. In order to register with TownSq, you will need your account number and the unit zip code 45424. If you are having issues with your TownSq account, please contact TownSq's technical support number at 844-281-1728 or by e-mail at support@townsq.io.
- 2. Association Fee payments may be made by online payment (via TownSq) or by mail. For online payments, there is a \$2.95 fee to pay from a checking account (with checking/routing information). If using a debit or credit card, there is an additional fee of 3.5% of the total amount paid. Please note that Associa, Community Management Solutions does not charge these fees; they are charged by the payment processing company. To avoid these fees, you may choose to mail a check*. Checks must be made payable to Forest Ridge Association and mailed to the bank lockbox; Forest Ridge Association c/o Associa, Community Management Solutions, P.O. Box 88396 Carol Stream, IL 60188-0396. To help ensure accurate and timely processing, please be sure to include your account number 00225-3787, our management company ID number (6630), and the corresponding property address on the memo line of the check. *When using this method of payment, it is recommended that you send payment at least two weeks before the due date to account for any potential delays with USPS.
- 3. Customer Service is provided by Associa, Community Management Solutions. The office is open Monday through Friday from 8:30 am to 5:00 pm. Should you have any questions relative to your account, please contact our Customer Service Department via TownSq, telephone (888-612-2299), or e-mail (customerservice@rpmanagement.com). Due to the high volume of calls, and the fluctuation in said volume, please be sure to leave a message if you reach voicemail. Sending a request on TownSq or an email to the Customer Service Department generally results in a faster response time. It is our goal to respond to all communications within 1-3 business days.

FOREST RIDGE ASSOCIATION SWIMMING POOL INFORMATION

Health and Safety

- * WARNING: CORONA VIRUS may be present; use pools at your own risk
- * If you do not feel well or are sick, entry into the pool area is prohibited. Additionally, admission may be refused based on health concerns observed by the staff (illness, abrasions, bandages, etc.).
- * There is a water fountain with bottle fill station available. Bottled water can also be purchased at the concession window. Additionally, members may bring personal drinks in non-glass containers.

Pool Grounds Rules

- * FRA is not responsible for loss, theft or damage to property.
- * No loitering. Anyone causing a disturbance will be asked to leave.
- * Destruction of pool property will not be tolerated.
- * No glass containers.
- * No food in the pool.
- * No alcoholic beverages.
- * Please place trash in proper receptacles.
- * No pets.
- * No profanity.
- * Smoking in designated areas only.
- * Bikes must be parked in the bike rack area ONLY. Please lock up your bikes.
- * No running, pushing, wrestling or rough-housing.
- * No violence or threats of violence will result in immediate suspension.
- * Staff may stop any unsafe action taking place.

Pool rules are for the protection and benefit of all members and guests and have been adopted to secure safe operation of the pool. The Board of Trustees has empowered the Pool Committee, Pool Management Company or staff member in charge with the authority to suspend or expel anyone who does not comply with rules or instruction of onsite staff.

ALL RULES WILL BE STRICTLY ENFORCED

Admittance

- * Everyone must have a pass or be an authorized guest.
- * All swimmers under the age of 10 must be accompanied by a guardian or the guardian's designee who is 13 or older. To appoint a designee, the guardian must accompany the swimmer on the first trip to the pool to provide written permission and an emergency contact number.
- * Children ages 10 12 may come to the pool unaccompanied with written guardian permission. The guardian must accompany the swimmer on the first trip to the pool to provide written permission and an emergency contact number.
- * Extended Hours and Breaks We have reduced lifeguards on duty during breaks and Extended Hours. Persons must be/be accompanied by a Responsible Swimmer to remain in the water.
- * Responsible Swimmer someone who is 15+, confident and competent in deep water, and mature enough to be responsible for their own or another's water life safety. Lifeguards have final authority to determine if a person is a Responsible Swimmer.

Guest Passes

- * 4 Single Day guest passes are free per lot/season.
- * Single Day guest passes: Adult \$3, 6 & under \$1.
- * Weekly (\$ 12). Monthly (\$ 35). Seasonal guest passes (see manager) are also available to house guests or baby sitters ONLY, and are limited to 4 per lot.
- * 1 non-swimming adult guest in street clothes is free.
- * Pool manager may limit the number of guests admitted per member at any one time.

- * Two sessions: June 6-17 and June 20-July 1st.

FOREST RIDGE ASSOCIATION SWIMMING POOL INFORMATION

General Swimming Policies

- * Proper swim attire is required. Thongs and transparent clothing are not permitted. We reserve the right to determine the appropriateness of swimwear.
- * Obstructing ingress/egress points is not permitted.
- * During periods of peak activity, staff may limit the number of swimmers in the pool.
- * All swimmers may be required to pass a basic swim test at the discretion of staff in order to determine if swimmer is safe in water over his or her head.
- * A rest period may be required if fatigue or chill is observed by the staff.
- * Breaks occur 15 minutes before the hour (excluding the last operating hour) and last for 15 minutes. Only those who are/are accompanied by a **Responsible Swimmer** may remain in the water.
- * Diving board may be closed at staff discretion. Front dives only. No horseplay or swimming in the diving well. Flotation devices are not permitted in the diving well.
- * Coast Guard (USCG) approved flotation devices may be allowed at staff discretion.
- *Wading Pool Zone: Restricted to children 44" or under. All children must have a **Responsible Swimmer** with them in the Zone at all times. Lifeguard duties do not extend to the wading pool.
- * Competition Pool: Two lanes will be reserved for lap swimming. During peak swim times, pool may be opened for general use. After 4pm, lap swimmers receive preference for use.

Discipline Procedures

* 1st Offense: Warning

* 2nd Offense: Sit out for staff specified period of time

* 3rd Offense: 3-day suspension

* 4th Offense: 7-day suspension and review by pool committee for possible seasonal expulsion

In cases of serious infractions, the pool staff may escalate the discipline procedures as needed. Upon swimmer suspension, once the penalty period has passed, a parent/guardian signature will be required for the suspended swimmer breturn to the pool.

2022 Special Pool Dates

- * Pool Opens May 28th
- * Independence Day Party July 4th.
- * Pool Raft Party August 6th.
- * Last Day of Swim Season September 5th
- * Doggie Swim September 6th (6:00 to 8:00)

Private Parties

- * Scheduled by request to pool manager.
- * Start after 8:00 pm and must end by midnight.
- * 2-hour minimum duration.
- * \$ 90.00 deposit to reserve date, balance due by the start of the party.
- * Cancellation must be received 3 days in advance of the party for a full refund.
- * FRA initiated cancellations will result in full refund.
- * Fees will be on an hourly rate as follows:

< 25 people -- \$ 90 per hour 26-50 people -- \$ 120 per hour 51-100 people -- \$ 150 per hour

- * Alcohol for personal consumption is permitted; no glass containers.
- * ALL other pool rules/policies apply during parties.
- * Manager may terminate a party without refund for failure to adhere to these rules.

The pool may have special operating hours at the beginning and/or end of the season due to lifeguard availability. These hours will be posted at the pool entrance in advance.

The pool may be closed for maintenance, weather or other emergencies as needed with or without advance warning. The pool may also be closed to general use for FRA sanctioned events, such as home swim meets. Swim meet dates will be posted in advance.

CATALYTIC CONVERTER THEFT

Why do people steal catalytic converters?

Catalytic converters are increasingly a target for thieves due to:

- . The current market value of a catalytic converter's precious metals
- . The ease of removing a catalytic converter for an experienced thief
- . The inability to track catalytic converters

In the current market, catalytic converters can be resold to recyclers for as little as \$50 or to precious metal dealers for as mu as thousands of dollars per ounce, reported the National Insurance Crime Bureau (NICB).

Because advanced models of catalytic converters include even more precious metals than older models, thieves have an increasingly attractive opportunity to make quick cash.

Experienced thieves can remove a catalytic converter in minutes, especially with modern power tools, according to Edmunds Plus, there are no tracking systems on a catalytic converter.

Cars that are often targeted for catalytic converter theft

Fuel-powered vehicles manufactured after 1974 have catalytic converters, so there are a lot of cars on the road that might ap to catalytic converter thieves. However, thieves often target taller vehicles, like pickup trucks or SUVs, because they can easi under the vehicle to access the catalytic converter.

Another attractive target for catalytic converter thieves are hybrid cars, according to Forbes. Because hybrid cars don't run a as gas-powered vehicles, their catalytic converters offer an even greater supply of precious metals.

How to tell if your catalytic converter has been stolen

You may not be able to tell your catalytic converter was stolen by looking at your car, but you'll know as soon as you start the engine. When the catalytic converter has been removed, your vehicle will make a loud roaring sound that'll get louder as you p the gas pedal.

Your car might also make a sputtering sound as you change speed, or you'll notice it's not driving smoothly.

An increase in the exhaust — or the exhaust smells — can be a definite sign of a stolen catalytic converter.

In summary, here are the key symptoms that your catalytic converter has been removed:

- Loud roar when you start the car, louder as you accelerate
- Increase in exhaust fumes, or unusual exhaust smells
- Missing parts under vehicle leading to muffler
- Uneven or sputtering acceleration due to lack of exhaust regulation
- Check engine light or inspection failures

5 ways to protect against catalytic converter theft

Consider these tips to help protect your car from catalytic converter theft:

- Know if your car is a likely target: hybrids, SUVs and trucks have valuable or easily removable catalytic converters. Etch y
 license plate number or VIN onto your catalytic converter this may help alert a scrap dealer that it was stolen and mal
 easier to identify the owner.
- 2. Park in well-lit areas close to public entrances, regularly move your car's spot or use a closed garage.
- 3. Install an anti-theft device
- 4. Install motion-sensitive lights and cameras in your parking area
- 5. Paint your catalytic converter to deter buyers some local police departments even offer free programs for painting

Understanding when your car might be a target for catalytic converter theft is the first key to preventing it. By following these protective measures, you may help deter thieves from targeting your car.
